

# An Evening of Jumping with Renee King

This workshop will begin with a discussion, lecture, and demonstration of jumping. You will learn the language of jumping...Inverted, Rounded, Flat, Extension, Collection, How to count strides, Linda Mecklenburg's Recall to Heel Exercises, and why it all matters. After the discussion/demonstration, you will work with your dog on the exercises and jump grids. At by the end of the evening, you and your dog will be confidently navigating jumping sequences with your new knowledge.

All participants should bring a willingness to learn, and pens, highlighters, and paper to take notes. Working spots should bring buckle collar, lead, slip lead, and plenty of "easy to dispense in small amounts" type of treats. You may crate ringside out of your car, or tie to the fence posts when not working.

The workshop will be limited to 10 working spots, and unlimited Audit spots.

Bitches in heat, lame, or blind dogs are ineligible to participate. Any dog which demonstrates aggression towards any person or any dog will be excused.
